Masons and their Dependants can now also be directed to a free, confidential Counselling Service.

Since it was established in 1990 the Fund has, thanks to the continuing generosity of so many, been able to provide grants for over 8,000 individuals ranging in age from 6 months to 104 years. It currently allocates an average of £10,000 per day in support of those in need.
